- The Superintendent's base salary shall be \$235,000, payable in equal monthly installments.
- Superintendent shall receive an annual stipend in the amount of \$1,416 in recognition of his Doctorate Degree.
- The Superintendent will be entitled to the same health and welfare benefits that are offered to other certificated management employees.
- Superintendent shall receive a \$250 monthly stipend for business use of his personal cell phone.
- Actual and necessary costs for business related expenses incurred due to travel outside of district boundaries will be reimbursed upon submission of appropriate receipts as ordinarily required of any employee seeking reimbursement.
- Superintendent shall have a work year of 215 days. He will not accrue vacation.
- District agrees to pay the Superintendent's membership dues in ACSA and the Northern California Superintendent's Group.

On the motion by Trustee Nonn and second by Trustee Gillies, Trustees voted 5-0 to approve the Employment Agreement for District Interim Superintendent.
