Parcel Tax Exemption Application

Instructions

1. Property owners who are over **65 years of age or older on June 30, 2023**, or those individuals who receive Supplemental Security Income for a disability, regardless of age may claim an exemption from the 2023-24 parcel tax by submitting this application with the requested documentation.
2. This parcel tax exemption is for your principal place of residence only.
3. You only need to apply one time for the parcel tax exemption. Once your application is approved, you will receive the exemption for the entire term of the parcel tax so long as you remain eligible. However, if you are granted an exemption, from time to time, the District may ask you to verify your eligibility.
4. The parcel tax applies to parcels with land value. If your parcel is taxed for improvement value only (as in some mobile home parks), the parcel tax will not be assessed on your parcel, and you do not need to fill out this application.
5. To find your Parcel Number, look for the 12 digit number (XXX-XXX-XXX-XXX) on your property tax bill.
