President Farrell called the meeting to order at 5:00 PM at the Mountain Shadows Educational Center, 7165 Burton Avenue, Rohnert Park, CA 94928.

Superintendent Haley opened nominations for President of the Board of Trustees. Trustee Orloff nominated Trustee Farrell and Trustee Wiltermood seconded. Trustee Nonn nominated Trustee Brown and Trustee Brown seconded the nomination. There were no further nominations. Superintendent Haley called for a roll call vote on the nomination of Trustee Farrell for Board President.

Trustee Farrell was elected President of the Board of Trustees by a vote of 3-2. Trustee Brown and Trustee Nonn voted no.

Trustee Farrell nominated Trustee Orloff and Trustee Orloff seconded. Trustee Nonn nominated Trustee Brown and Trustee Brown seconded. There were no further nominations. President Farrell called for a vote. The vote was 2-3 to nominate Trustee Orloff. Trustees Brown, Wiltermood and Nonn voted no.

Trustee Brown was elected Clerk of the Board of Trustees by a vote of 3-2. Trustees Farrell and Orloff voted no.

President Farrell then opened nominations to elect a representative to the Sonoma County Office of Education. Trustee Brown nominated Trustee Nonn and Trustee Nonn seconded. President Farrell nominated Trustee Wiltermood and Trustee Orloff seconded. The vote was 2-3 to nominate Trustee Nonn. Trustees Farrell, Wiltermood and Orloff voted no. Trustee Wiltermood was elected by a vote of 4-1 to act as representative to the Sonoma County Office of Education. Trustee Nonn voted no.

President Farrell designated representatives for the following committees: Trustee Orloff and Trustee Wiltermood will be the district representatives to the cities of Cotati and Rohnert Park. Trustee Orloff and Trustee Wiltermood will serve on the Local Control Accountability Plan Committee. Trustee Farrell and Trustee Orloff will serve on the Facilities Committee.
