The Cotati-Rohnert Park Unified School District ("District") and the California School Employees Association (CSEA), Chapter 645 ("Association"), jointly known as the Parties ("Parties") enter into this Memorandum of Understanding ("MOU") regarding the issues related to the 2023 Summer Program.

## 1.0 DEFINITION

1.1 "Summer Program" - Summer Program pertains to all students participating in the TK-12 grade programs, including Extended School Year (ESY), Summer Enrichment Academy (SEA), and Credit Recovery (CR).

## 2.0 DATES AND HOURS

2.1 Summer program will consist of Friday, June 9, 2023 and end on Wednesday, July 14, 2023. Summer Program will be closed on June 19, 2023 in observance of Juneteenth and on July 3-4, 2023 in observance of Independence Day. Unit members will receive holiday pay for June 19, 2023 and July 4, 2023.

#### 3.0 COMPENSATION

3.1 Unit members will be compensated at the current range for the position they are filling for the summer program, and the unit member's current step, including longevity. Unit members will receive an additional daily bonus of \$24 for days worked. They will not receive the \$24 daily bonus for June 19, 2023 or July 4, 2023.

3.2 Any additional hours that are approved to be worked by the Food Service Coordinator will be paid at the unit member's current hourly rate in 15 minute increments.

## 4.0 SELECTION OF SUMMER PROGRAM STAFF

4.1 First priority for hiring of summer program staff will be provided to currently employed staff, based on programmatic need. If no bargaining unit members accept the assignment, the District shall use its regular recruitment procedures to fill the positions.

# 5.0 SUNSET OF THIS MOU

5.1 This MOU will expire without precedent at the close of business on July 14, 2023 unless mutually extended, or shortened, in writing by the parties.
