

## **TENTATIVE AGREEMENT**

# ROHNERT PARK COTATI EDUCATORS ASSOCIATION

May 20, 2024

- 1. Wages (Article 15)
  - a. \$2000 added to each cell on the salary schedule comprised of the following:
    - i. Wage increase of \$1253
    - ii. Transfer of the \$747 Bilingual Stipend
  - b. Fully Credentialed Teacher Salary Schedule
  - c. Non-Fully Credentialed Teacher Salary Schedule
  - d. Speech-Language Pathologist Salary Schedule
  - e. Nurse Salary Schedule
  - f. Elementary Counselor Salary Schedule
  - g. Secondary Counselors
    - Addition of 3 calendar days for secondary counselors, for a total of 195 work days.
    - ii. Secondary Counselor Salary Schedule
- 2. Probationary credit calculations (Article 2)
- 3. Removal of language for a program no longer offered (ROP) (Article 2)
- 4. AB119 Notification of unit member lists to RPCEA/CTA to reflect law (Article 8)
- 5. Completion of Meet and Negotiation/Savings and Duration (Article 24 and Article 26)
  - a. Reopeners for 2024-2025 school year:
    - i. Articles 4, 6, 7, 8, 11, 14, 17, and 25 (already sunshined)
    - ii. Wages
  - b. Duration: July 1, 2024 June 30, 2027
  - c. We will continue to confer and address additional contract issues as they arise.
  - d. For the 2025-2026 school year, we are committed to have reopeners by May 31, 2025.

The parties agree to recommend the approval of this tentative agreement to their respective constituents.
