## MEMORANDUM OF UNDERSTANDING BETWEEN COTATI-ROHNERT PARK UNIFIED SCHOOL DISTRICT AND CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS COTATI-ROHNERT PARK CHAPTER 645

## Summer Hours Night Custodian March 13, 2024

The following constitutes a Memorandum of Understanding between the Cotati-Rohnert Park Unified School District ("District") and the California School Employees Association, Chapter No. 645 ("CSEA").

**Background:** Due to the increase in night activities, athletics and the expanded learning program, Night Custodians may need to perform work during the summer at times that are different than their regular summer assignment.

The parties agree to the following:

- Effective ratification, the following contract language will be amended as written below:
  - o 4.9 Custodial Differential Compensation
    - 4.9.1 For the months of June, July, and August, night custodians shall be compensated at the Custodian/Maintenance/Groundskeeper salary, Range 21. For this additional compensation the night custodian will <u>may be assigned to</u> work days during all school vacations and non-student days and will <u>may be assigned to</u> perform maintenance and grounds work during all school vacations and non-student days. For the purposes of this differential compensation, placement on the Custodian/Maintenance/Groundskeeper salary schedule will be at the same step as the employee's current step on the custodian salary schedule.
- Night custodians will receive their summer assignments by May 17, 2024.
- This MOU will expire without precedent at the close of business on August <u>31</u>, 2024 unless mutually extended or shortened in writing by the parties.
